1. INTRODUCTION:

Hamidia Girl's Degree College is a Constituent Minority College of the University of Allahabad functioning under the aegis of The Association for the Education of Muslim Women at Allahabad. It caters to the needs of modern higher education of girls and women in the densely populated Muslim dominated area. It has maintained its accessibility to all sections of the society, especially Muslim girls. The college is a unique centre of quality modern higher education and vocational skills. Presently approximate 2000 girl students are enrolled in the College in three faculties.

The Vision of the College is to make it a globally acknowledged competitive centre of excellence by providing modern, scientific, technological and value-based education accessible to the under-privileged girls of the minority community as well as other underserved segments of the society and to bring them into the mainstream of national development.

C. Other Projections:

Revival of Dying Art of Urdu calligraphy: The collage runs Urdu Calligraphy sanctioned by U.P.Urdu Academy since 2006. Since then 11 batches have passed successfully. Each year 20 students are enrolled. A Calligrapher is engaged to teach the students. The salary is paid by U.P. Urdu Academy .The Academy also gives scholarship to students; the first year students are given Rs 150 per month & Rs 200 per month to second year student .This course has revived interest among the students about the dying art. Following activities were undertaken

- Dr. G. SKhawaja Director Pura lekh Shakha, Nagpur & trained Mr. Reyaz Ahmad students to write in Calligraphy style for books
- Dr. Rajesh Purohit , Director Museum Documentary film on Khusro Baag
- 20 Students participated in an exhibition of Calligraphy samples.
- Instruction Mr. Reyaz made Calligraphy ink in the indigenous style. Students were trained how to use the paper & calligraphy ink.

URDU COACHING : U.P.Urdu Academy has sanctioned Urdu Coaching (6month certificate course)for students above 16 years of age .It is functional and since 2011 10 batches have passed with 100%result .The objective of the scheme is to promote urdu literacy among those students who have not studied Urdu. The academy provides set of five books to the enrolled students. The salary

of the instructor is given by U.P. Urdu Academy. This coaching is equivalent to class VIII pass course. Fifty students are enrolled in this coaching every year.

REGULAR HEALTH CHECK-UPS

Improving Women's Health is one of the two key areas of action adopted by the Centre for Women Studies. Regular health check-ups were conducted by the Consultant Doctor of the Centre, Dr. Anjum Ahmad, Sr. Consultant, Zila Mahila Chikitsalaya. In the session 2017-18, 210 students have been examined and a Health Card recording their weight, B.P. has also been issued in their name. Dr. Anjum Ahmad counselled students on *Women's Health and Hygiene & Women and Stress Management*.
